### Requirements for All Vendors

- Booths must be set up by 4:00pm on Sunday at your assigned area and have personal vehicles removed from the vending area no later than 3:30 p.m.
- Vendor must be staffed and remain open from Sunday 4pm-9pm and Monday, 9am-7pm (inside booths) or 9pm (outside booths)
- A copy of the State of Texas Sales Tax Permit must be on site.
- **Booths requiring electricity will be provided one (1) 110v outlet. This will satisfactorily support lighting for a booth. For additional electrical needs, vendors must bring their own generator. Scurry County Parks and Recreation, the City of Snyder, nor the Chamber of Commerce can guarantee uninterrupted electrical service.**
- All vendors must supply their own tables, extension cords, trashcans and generators for their booth.
- All vendors will be subject to an inspection by the local fire department prior to opening to the public. If they find any violations, you will not be allowed to operate until these violations have been rectified.
- Must provide one serviceable 10 lb Dry Chemical (Type A, B, C) extinguisher on hand. Extinguisher should be readily available at each location.
- ANY flammable fuel (propane, butane, gasoline/diesel for generators only) must be stored in an approved container, and a minimum separation distance of 35ft from any open flame will be required for storage of all fuel.
- All vendors will be required to clean up around your area after tearing down.
- Under no circumstances will we accept any vendors after Friday, June 17, 2011.

### Special Requirements for Food Vendors

- All food vendors must have a valid food permit.
- Scurry County Health Unit requests that menus be simple and only offer a few options
- Generators will be required for all Food Vendors utilizing Refrigerators, stove, electrical cookers, slow cookers and/or microwaves
